Community agencies: partners in accession

We have commemorated significant political developments in European history in 2009: the 20th anniversary of the fall of the iron curtain and the fifth anniversary of an extensive wave of European Union enlargement. Looking to the future, this year has also marked the ratification of the Lisbon Treaty by all European Union Member States.

Europe is a different place now than it was 20, or even 10 years ago. Consequently, a European Union of 27 Member States faces new challenges, including helping candidate and potential candidate countries prepare for participation in the work of Community agencies. This is not a new task, but the nature of technical cooperation, its objectives and modalities are becoming more complex and require a new approach. Community agencies have a special role to play in helping third countries become familiar with European practices and the range of cooperation mechanisms in existence.

Today's conference, called 'Community agencies: partners in accession', has been organised by the EMCDDA at the request of the European Commission to contribute to this process. The audience of policymakers from IPA beneficiary countries, representatives from EU Member States, the European Parliament, the European Commission and the agencies themselves have been brought together here in Sintra to share experiences and learn more about each other. We hope that the information on offer on procedures for participating in the work of the agencies, useful tips and advice will contribute to giving new impetus to the actions in the Pre-Accession Assistance Programme.
