Session 4: COVID and DRD: Rapid assessment from the EURO-FOTON and toxicologists networks Chair: Pirkko Kriikku, Finland and Isabelle Giraudon, EMCDDA

Objectives: This session provides a specific forensic toxicology perspective on the question of the impact of the COVID-19 pandemic on overdoses. It also aims to assess whether the format of ONLINE structured discussion with a network of experts is feasible and can bring first hand and timely information of drug-related deaths.
