

COOPERATION AND OUTPUTS

Western Balkan countries

The EMCDDA has been working with Albania, Bosnia Herzegovina, the former Yugoslav Republic of Macedonia, Kosovo (*), Montenegro and Serbia since 2008. Thanks to EU funding tools, such as the Instrument for Pre-Accession Assistance (IPA), the candidate and potential candidate countries to the European Union can already participate effectively in the activities of the EMCDDA prior to EU accession.

The EMCDDA develops activities designed to help the partner countries understand how the Centre operates. It also enables candidate and potential candidate countries (IPA beneficiaries) to involve other relevant national stakeholders in their activities in ways similar to those of EU Member States. The EMCDDA carries out preparatory measures such as training activities, study visits, workshops, conferences and outreach actions. Activities also include the preparation of documents such as manuals, guides, reports and other relevant documents for the benefit of the IPA beneficiaries.

Through the range of training capacity activities carried out in the IPA beneficiaries which support the countries concerned in the implementation and development of their national drug information systems, these countries are progressively collecting information and data following EMCDDA guidelines and methodologies. National representatives also regularly attend the EMCDDA's expert meetings, which enables them to understand better the methodologies developed and hence guarantee an effective implementation at national level.

A follow-up project has been confirmed by the European Commission and is scheduled to start in autumn 2015.
