# **European Drug Report 2016**



What are the latest trends in drug supply to Europe?
What drugs are causing the most harm and concern today?
What are the most recent developments in drug prevention, treatment and policy? These and other questions will be explored by the EMCDDA in its annual overview of the European drug situation to be launched in Lisbon on 31 May. The European Drug Report 2016: Trends and Developments provides a comprehensive analysis of the

latest tendencies across the 28 EU Member States, Turkey and Norway. Available in 24 languages, the report examines: drug supply and the market; drug use prevalence and trends; and drug-related health problems and responses to them.

The report will be launched at a press conference in Lisbon on 31 May at 10:00 WET (11:00 CET) in the presence of: Dimitris Avramopoulos, European Commissioner responsible for Migration, Home Affairs and Citizenship; Laura d'Arrigo, Chair of the EMCDDA Management Board and Alexis Goosdeel, EMCDDA Director.

# Perspectives on Drugs

The EMCDDA will release alongside the *European Drug Report 2016* on 31 May four new additions to its *Perspectives on Drugs* series. These online interactive analyses focus on key aspects of the European drug situation. The topics explored are: changes in Europe's cannabis resin market; cocaine trafficking to Europe; strategies to prevent the diversion of opioid substitution treatment medications; and co-morbidity of substance use and mental health disorders.

# International day against drug abuse and illicit trafficking



The EMCDDA will commemorate International day against drug abuse and illicit trafficking (26 June) with an event at its premises on 27 June for the Lisbon diplomatic community and its partners from the Portuguese authorities. To mark the occasion, the agency will launch a new report on 'Health responses to new psychoactive substances' and an accompanying analysis on the topic

in its *Perspectives on Drugs* series. Also highlighted on the day will be the EMCDDA *General Report of Activities 2015* and *A year in review 2015*.

# European drugs summer school 2016



The University Institute of Lisbon (ISCTE-IUL) and the EMCDDA will be holding the fifth European drugs summer school (EDSS) on 'Illicit drugs in Europe: demand, supply and public policies' from 27 June to 8 July in Lisbon. This year, the focus of the course will be on the evidence base for policymaking on drug-related issues. President of the International Narcotics Control Board Werner Sipp will speak on 'The global drug control system: what is the UNGASS process and what to expect from it?' Keynote speaker Keith Humphreys of the Stanford School of Medicine (USA) will explore

'Drug policies: concepts, issues and analysis', while Robert West, Editor-in-chief of the scientific journal *Addiction*, will focus on scientific communication and policy decisions. Registration ends on 30 May.

# World hepatitis day 2016



Transmitted through the sharing of needles, syringes and other injecting equipment, hepatitis C is highly prevalent among people who inject drugs in Europe. This year the EMCDDA will mark World hepatitis day on 28 July with the release of a new report dedicated to hepatitis C treatment for drug users in Europe. Hepatitis C infection is often

asymptomatic and can go for years undiagnosed. Many of those infected go on to develop chronic hepatitis and are at risk of developing liver disease (e.g. cirrhosis, cancer).

# Upcoming report on drug use among school students



The latest European data on substance use among 15–16-year-old school students (2015) will be released in the coming months by the European school survey project on alcohol and other drugs (ESPAD).

The report, published with the EMCDDA, will be launched in Lisbon on 20 September following a

meeting of the agency's general population surveys expert group. ESPAD has been collecting data through school surveys every four years since 1995, the latest wave coinciding with its 20<sup>th</sup> anniversary. The number of countries participating in the survey has increased over the years: 35 countries participated in the 2015 survey (100 000 respondents).
