EMCDDA budget for 2013

Summary

The proposed EMCDDA budget for 2013 takes into consideration the 2007–13 reference budget framework for the EU annual subsidy to the EMCDDA, in accordance with the latest information available on the relevant financial programming of the European Commission.

The proposed budget reflects some necessary adjustments compared to the EMCDDA 2013 preliminary draft budget (PDB), in order to take into account some changes in the conditions that were assumed at the time the PDB was adopted in December 2011.

In this context, the proposed budget provides the resources needed to enable the EMCDDA to ensure the implementation of its 2013 work programme (see document EMCDDA/24/12), in accordance with its recast founding regulation and its three-year strategy and work programme for 2013–15.

With regard to the above, the EMCDDA 2013 budget enters the following appropriations as main revenue:

- EUR 15 550 000 to be provided by the EU 2013 subsidy to the EMCDDA;
- EUR 407 482 to be provided by Norway for its participation in the EMCDDA.

Furthermore, the proposed 2013 budget enters into its revenue EUR 100 000 for Turkey's contribution in 2013 (amount required in the agreement for the first year of participation and assuming that this agreement will enter into force on 1 January 2013).

The European Commission has decided to award the EMCDDA EUR 900 000 under the IPA programme to implement a project for technical assistance aimed at preparing IPA beneficiaries for their participation in the EMCDDA (the so-called IPA 4 project) during the 2012–14 period. Pursuant to this decision and according to the relevant financing agreement, the EMCDDA 2013 budget enters EUR 350 000 as assigned appropriations for the execution of this project in 2013 (second year of execution).

Decision

The Management Board adopts the proposed EMCDDA 2013 budget in accordance with Article 14(8) of the EMCDDA founding regulation.

1. Background and introduction

In December 2011, the Management Board (MB) adopted the EMCDDA preliminary draft budget (PDB) for 2013. This PDB entered EUR 16 100 000 as revenue to be provided by the EU subsidy to the EMCDDA for 2013.

In March 2012, within the context of the EU draft budget, the European Commission (EC) proposed EUR 15 550 000 for the EU subsidy to the EMCDDA 2013 budget (EUR 15 397 000 from appropriations to be charged to the EU 2013 budget and EUR 103 000 from available surplus of the EU subsidy to the EMCDDA, resulting from previous financial years).

In its position on the EU 2013 draft budget, the Council considered that the amount proposed by the EC should be further reduced by EUR 170 919. In this context the Council considered also that in 2013 the EMCDDA's establishment plan should be reduced by one AD 8 post for temporary staff. Pursuant to the latest available information, in its reading of the EU 2013 draft budget the European Parliament expressed a favourable position on the aforementioned EC proposal.

Without prejudice to the possible outcome of the EU 2013 budget procedure, it is assumed that the 2013 EU subsidy to the EMCDDA will correspond to the amount proposed by the Commission.

The agreement between the EU and Turkey for the participation of the latter in the EMCDDA's activities was ratified by both parties, but it has not yet entered into force, as the necessary notification process has not been completed. It is assumed that this process will be completed by January 2013 and that 2013 will be the first year of Turkey's participation. The amount entered for Turkey's 2013 budget contribution is consistent with this assumption. Furthermore it is assumed that Croatia will not contribute to the 2013 EMCDDA budget, given that its accession to the European Union should be effective from 1 July 2013.

These assumptions entail a reduction in the revenue assumed and entered in the EMCDDA 2013 PDB, as adopted by the Management Board in December 2011.

Finally, the proposed 2013 budget takes into account that no information is available at present about possible supplementary appropriations to be provided by the EU budget in 2013 to cope with the impact of the forthcoming accession of Croatia.

With regard to the above, the proposed EMCDDA 2013 budget reflects some necessary adjustments compared to the adopted EMCDDA 2013 PDB.

2. Key features of the EMCDDA budget for 2013

The proposed EMCDDA budget for 2013 takes into consideration the 2007–13 reference budget framework for the EU annual subsidy to the EMCDDA, in accordance with the latest available information on the relevant financial programming of the European Commission.

In this context, the proposed budget provides the resources needed to enable the EMCDDA to ensure the implementation of its 2013 work programme (see document EMCDDA/24/12), in accordance with its recast founding regulation and its three-year strategy and work programme for 2013–15.

With regard to the above, the EMCDDA 2013 budget enters the following appropriations as main revenue:

- EUR 15 550 000 to be provided by the EU 2013 subsidy to the EMCDDA;
- EUR 407 482 to be provided by Norway for its participation into the EMCDDA.

Furthermore, the proposed budget for 2013 enters into its revenue EUR 100 000 for Turkey's contribution in 2013 (amount required in the relevant agreement for the first year of participation and assuming that this agreement will enter into force on 1 January 2013).

The European Commission has decided to award the EMCDDA a financing of EUR 900 000 under the IPA programme to implement a project for technical assistance aimed at preparing IPA beneficiaries for their participation in the EMCDDA (the so-called IPA 4 project) during the 2012–14 period. Pursuant to this decision and according to the relevant financing agreement, the EMCDDA 2013 budget enters EUR 350 000 as assigned appropriations for the execution of this project in 2013. The

remaining amount of the financing (EUR 200 000) will be entered as assigned revenue in the EMCDDA budget for 2014.

In more detail, the 2013 budget should allow the EMCDDA to:

Under budget Title 1

- Cover the salary costs for all staff in post and the supplementary expenditure needed to meet
 usual estimated adjustments required in 2013, in accordance with the applicable Staff
 regulations (automatic staff progression to the next step; annual adjustment of staff
 remuneration decided by the Council of the EU on the basis of changes in the cost of living;
 estimated staff promotions in accordance with the rates indicated in the EMCDDA's Staff
 policy plan). This includes the expenditure required to cope with the estimated cumulative
 impact of the 2011 and 2012 adjustment of staff remuneration, which depends on the ruling of
 the EU Court of Justice on the pending case (expected for early 2013);
- Fully deploy the establishment plan authorised under the previous annual budget, no additional posts being requested.

Under budget Title 2

• Meet the estimated costs of the administrative and IT support services and supplies required for the management and functioning of the EMCDDA's premises and infrastructure, pursuant to the conditions resulting from the contract in force for the lease of these premises. In particular, the appropriations entered in Title 2 will enable the EMCDDA to comply with the relevant budgetary and legal commitments, taking into account the automatic revision of prices, as entailed by the estimated variation of the inflation rate and the legal indexation of the rent to be paid for the lease of the EMCDDA's premises. Any possible investment in this area will be considerably reduced to cover just the minimum essential needs. Furthermore, it is assumed that the areas in the Relogio building (Palacete) that were previously occupied by the Jacques Delors Information Centre will be sub-leased in 2013 and that the tenant will bear his share of utility costs. Finally, no supplementary appropriations are expected at this stage from the selling or leasing of the Santa Apolónia building, taking into account the current situation and the negative outlook for the real estate market.

Under budget Title 3

- Ensure the execution of planned operational activities and projects to implement the proposed EMCDDA 2013 work programme, in accordance with the adopted EMCDDA strategy and work programme for 2013–15. In this context, a serious effort has been made to deal with the expected 2013 budget constraints, in particular via a considerable reduction to the expenditure for technical meetings, missions and publications, taking into account for the latter the revised approach for producing and publishing the EMCDDA Annual report.
- Ensure the EMCDDA's 2013 co-financing to the Reitox national focal points (NFP), by earmarking the total amount of appropriations which were earmarked in 2012. In this context, it is assumed that there will be no annual indexation (2 %) and that the total amount will include also the appropriations required for the pro-rata co-financing to the Croatian NFP as from 1 July 2013. Pursuant to the existing Reitox co-financing system, which provides for an equal maximum amount of EMCDDA co-financing for each NFP, this situation will entail a slight reduction of this maximum amount per NFP.
 In line with the technical solution implemented since 2010, the proposed 2013 budget enters in the relevant budget line (3151) 95 % of the possible total amount of the appropriations at stake.. The remaining 5 % has been earmarked under title 3 for other activities aimed at implementing the EMCDDA's work programme (publications, translation and dissemination, technical meetings, studies). If at a later stage it is necessary to commit these remaining appropriations in order to cope with the actual requests presented for the 2013 Reitox grant, they will be entered into the relevant line (3151) by means of budget transfer.
